TITLE: Catherine Street Bridge and Road Reconstruction Tender Award

OBJECTIVE

For Council to award the tender for the Catherine Street Bridge and Road Reconstruction project.

BACKGROUND

The Town of Ingersoll was successful in receiving funding from the Ontario Community Infrastructure Fund (OCIF) for the Catherine Street Bridge and Road Reconstruction project. As part of the agreement signed by the Town and the Province to receive the funding, Council must officially award the tender.

ANALYSIS

The tender for the Catherine Street project is a joint project between the Town, Oxford County and the Province. The tender was opened on April 22, 2015 with two bidders. After verifying the tender Elgin Construction out of St. Thomas was the low tender in the amount of \$1,724,884.05 this includes an extension of the watermain up Mutual Street for the County. The County has approved the awarding of the tender for their portion of the project.

FINANCIAL IMPLICATIONS

The estimate for the project was \$1,514,274 with an additional \$159,411 for the County's watermain project. The estimate was broken up into \$455,379 for the bridge/culvert and the remainder for the sanitary, storm, watermain and road reconstruction. The low bid from Elgin Construction tendered the bridge culvert at \$488,732 which is an additional \$33,353 and the roadwork was an additional \$7000 because of an increase in asphalt prices. The additional costs for the bridge culvert was due to an increase cost for the railing on the bridge, the retaining wall, the apron wall and the cost of bonding and insurance for this part of the project.

The County also had additional costs in the sanitary for Catherine Street due to the increase cost for sanitary sewer pipe and the extension of the watermain on Mutual Street due to the increase cost in asphalt.

Staff is recommending that the additional \$40,000 needed for the Town's portion of the project be taken from the Engineering Reserve and added to the Town's contribution of the project for the OCIF funding.

RECOMMENDATION

THAT report Number OP-048-15 be received as information and that the tender for the Catherine Street Bridge and Road Reconstruction project be awarded to Elgin Construction of St. Thomas for \$1,724,884.05.

AND FURTHER THAT an additional \$40,000 be taken from the Engineering Reserve to cover the additional costs of the bridge and roadwork.
